- Operation of the sanitary landfill,
- cStreet sweeping,

- The investments comprise of transport and waste collection equipment and units, cells, biogás plant, among others.
- Grantor.- Metropolitan Municipality of Lima / Government of Perú.
- Current operator solid waste operation (2016).- 635,600 tons per year.

 Public bid competitive variables.- Tariff discount, additional income participation, environmental care and reducing the emissions that cause climate change, technological innovation.

- It must comply with international health and environmental standars, optimize environmental services processes and generate electricity,
- The proposed contractual arrangement is for a 10 years period concession.

- 1. According to the bidding documents, bidders must pre-qualify crediting experience in the requested services, technical capacity for solid waste management, as well as financial capacity to ensure investments.
- 2. The evaluation of proposals will be in two stages: Enabling technical proposal, for which minimum technical requirements have been stablished and the economic proposal will define the winner based on financial and environmental factos.
